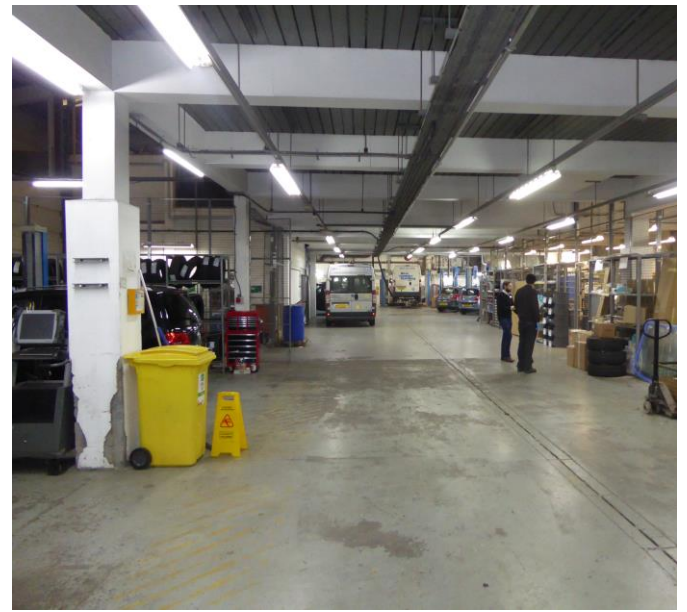

## LOCATION

Westbury is located approximately 12 miles southeast of Bath and 5 miles south of Trowbridge. Junction 17 of the M4 is approximately 16 miles to the north. It is located on West Wilts Trading Estate which is a large and well established estate on the northern side of the town. Occupiers include Buildbase, Heritage Commercial Vehicles, Rygor Mercedes Benz Commercial Vehicles and H&H Celcon.

## DESCRIPTION

The property comprises a large detached dealership, having previously been used as a Peugeot franchise. The main building is of a portal frame, part metal clad and part brick walls under a metal clad roof. The showroom has a wide frontage of 91ft to Broadway North.

The showroom enjoys external car display for 48 cars.

To the rear of the showroom is an extensive workshop with currently 12 bays, MOT bay and valet bays. The workshop has an eaves height varying between 6.5m and 7.4m.

To the rear of the building there is an extensive carpark for 80 cars.

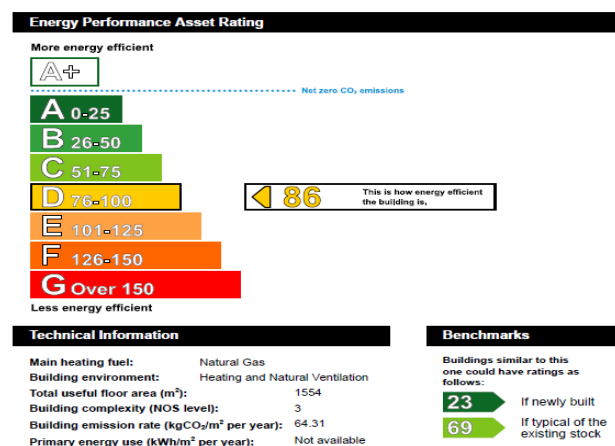
